### AD1-1 Notice

This Addendum No. 1, dated May 24, 2018, to the Request for Proposals: Janitorial Service, supersedes all contrary and conflicting information in the above-mentioned instructions, specifications, and contract documents which are hereby supplemented or revised in certain particulars as follows:

## **AD1-2 General Information**

The District submits this Addendum to answer questions, make clarifications, and provide information.

### **AD1-3 Instructions**

Proposer shall initial the bottom of this Addendum No. 1, and include it with his/her sealed proposal.

- Question 1: When will office remodeling be finished in the Maintenance Building?
- Answer 1: Within the next two months. All offices in the Maintenance Building will be tiled instead of carpeted.
- Question 2: Is the Maintenance Building men's locker room floor stripped and waxed, or machine scrubbed?
- Answer 2: This floor will be machine scrubbed quarterly until remodeling of this area is completed (in approx. 2 years). Depending on the floor material, contractor may be required to go back to stripping and waxing twice a year.

Admin Building: Elevator floor (in the garage; 6'X9') to be wet mopped weekly.

Maintenance Building: The large round hands-free sinks in the men's locker room are not functional; these do not need to be cleaned.

Operator's Building: An area will be designated for janitorial supply storage.

The water source is a garden hose outside the door.

- Aeration Building: Contractor is only responsible for the office to the right as the building is entered and the restroom.
- Lab: Request paper products, etc. for the Lab from Lisa in the Maintenance Building. Elevator floor to be wet mopped weekly (see section III, 3.4.E.5). Stairwell up to Lab to be cleaned daily.

General: Window cleaning: spot clean interior windows daily; if streaks are visible, clean entire window.

Area rugs must be vacuumed daily; Aramark changes rugs weekly.

Stairwells to be cleaned once per week.
