This Addendum Number 2, dated May 23, 2019, for the above referenced project, supersedes all contrary and conflicting information in the specifications and contract documents, which are hereby supplemented or revised as follows:

PROJECT SPECIFICATIONS

Section I

1. Bid Schedule, Page 24: The Bid Schedule on page 24 has been revised, eliminating ITEM 220 from the contract (308' of 24" DIA). Bidders shall replace Page 24 issued in Addendum No. 1 with the enclosed. The revised Bid Schedule attached shall be used in submitted bids.

Section II

- 1. Part 4, Sewer Flow Control: Additional clarification of source of flows provided in Addendum No.1 is provided below:
 - a. Items 30-34, 24" diameter: 1.90 MGD approximately 90% of flow is in 24" diameter tributary sewer.
 - b. Item 77, 18" diameter: 1.36 MGD approximately 90% of flow is in 18" diameter tributary sewer.
 - c. Items 216-219, 24" diameter: 4.05 MGD approximately 75% of flow is discharged via force main into MH 142-034. Max downtime for pump stations discharging to this location is estimated at 2 hours.
 - d. Item 221, 18" diameter: 1.49 MGD approximately 90% of flow is in 18" diameter tributary sewer.
- 2. Part 7.1.2 CIPP Structural Requirements, Item 1 (Page 90 of 102): Revise the first sentence of the last paragraph to read: "The finished thickness of cured pipe shall not vary from the nominal thickness specified or required by structural calculations by more than 10%."
- 3. Part 8.1.3 Sewer Service Reinstatement, Item 3 (Page 95 of 102): Revise Item 3 to read: "If the Contractor cannot determine through pan and tilt televising methods in the pre-lining video inspection if a service is live or in use, he shall notify the District immediately. The District shall perform the tests necessary to determine if the service is in use and provide instruction to the Contractor in regards to service reinstatement."

This information shall be taken into consideration when preparing your bid. This addendum will be E-mailed to all plan holders as well as posted to the District's website at www.rrwrd.dst.il.us.
