- **Question 1:** Can you please advise what exactly you are looking for with the Alarm System? Do you already have an alarm system in place that just needs monitoring 24/7? So would need an officer just sitting there?
- Answer 1: The alarm system in place is a Bosch RPS Lite, and this is activated during non-business hours. This includes motion sensors, glass breaks, and touch panels at each entrance. Management is done via remote access to the

server controlling the system, and is integrated with our network infrastructure. The guard responds to the alarm. The officer does not have to be just sitting there.

- **Question 2:** The very last page of the bid form where it says "ATTEST" is that filled out ONLY if we would get the bid?
- **Answer 2:** Yes. No part of the contract form is completed until the award has been made.
- **Question 3:** Is there a minimum # of hours you are wanting quoted for the "employee protection" above and beyond the 12 regular monthly board meetings?
- Answer 3: There is no minimum number of hours, please state the hourly rate. When the District is not operating under COVID 19 restrictions, there are at least 12 Board meetings per year. If the Board meetings are held via WebEx, guard service is not needed at those meetings.
