Engineering Manager Baer presented options for renovating the District's former Administration Building to serve as the new location for the District's North Facility. Baer provided visual layouts showing possible design options. In addition to housing a portion of the District's Supporting Services Department, the east side of the renovated facility could also be rented to Aqua Aerobics for training, demonstrations, etc. Tyler Nelson, RRWRD Engineering, was in attendance to answer any questions. At this time, this is informational only.

Operations Manager McFall provided an update on the state of nutrient reduction in Illinois. IEPA personnel had advised that the Nutrient Science Advisory Committee would issue a report in December, but IEPA has not yet released it and plans to do so after the first of the year. McFall anticipates cost of approximately \$100M over the next 10 years. More information will be available after report is released.

Supporting Services Manager Reader provided status of activity regarding sewer main line cleaning, televising crews, pipe replacement, manhole ticket backlog breakdown and manhole restoration for the month of November, as well as an overview of progress made throughout the past year.

Business Manager Black reported total revenue 1% over budget YTD. Operating expenses were 2% over budget YTD, and income statement reflects \$3,720,100 in net operating income through November 30, 2018. Cash increased \$7,902,917 for the 2018-19 fiscal year. General fund cash total at the end of the month was \$30,568,201. Total number of authorized full-time positions is 116; 116 filled.
