Baer presented the Board with a revised Final Application and Agreement with IEPA for Delegation of Construction and Permit Authority. No Board action required.

McFall reported that during the months of March and April the District has experienced slightly elevated levels of ammonia being discharged to the Plant. While the District remains compliant with its permit, it is still working to determine the source of the ammonia. The source appears to be located in a 10-20 block area east of the district and north of the Airport. The District continues to monitor and investigate.

Cassaro presented the Plant Operations Monthly Snapshot and Trend Report covering March and April, 2020.

Reader provided a status of Collection Systems activity regarding sewer main line cleaning, televising crews, pipe replacement, manhole ticket backlog breakdown and manhole restoration for the months of February and March, 2020.

Scott-Valdez reported that, as of the end of March, 2020, user fees are 20.1% below budget for the month, and 3.2% below budget YTD. Total revenue is 25.3% under budget for the month and 2.9% below budget YTD. O&M expenses are 1.75% below budget YTD. The income statement shows \$6,475,602 net operating income. The cash flow statement shows \$5,215,396 increase in cash for the FY. The General Fund cash ended the month of March at \$36,061,899. Scott-Valdez and Mittel are developing reports tracking loss of fees experienced due to the COVID-19 lockdown and will present the data to the Board this summer.
