(Note: ITS Supervisor Robertson advised that, because the product is software/electronics and related professional services, it is exempt from competitive bidding under the Sanitary District Act.)

Director Hanson advised that staffing changes to the Plant Maintenance Division (mentioned on the agenda) will be addressed under the Plant Operations Manager's report later in this meeting.

Hanson then advised his plan to restructure assignment of some responsibilities within the IWS Division, resulting in the creation of a Pre-Treatment Program Group Leader. The division will have a vacant position at the end of this month; therefore, total headcount will not be affected. No Board action required.

General Counsel Hanley provided a summary of two appearances before the Board which took place August 21, 2018. Hanley advised that District Administrative and Investigative Orders, which are issued as part of enforcement for industrial wastewater users, previously mandated appearances before the Board for any violations. The language of such orders has now been changed to state that violations may require appearances. In the case of both companies in question at these hearings, both had met with District staff prior to the appearances and had agreed on resolution plans. District continues to monitor both situations. No Board action required at this time.

Trustee Pollack moved to approve two Agreements for Variance, one at 5839-61 Forest Hills Road, and the other at 3402 S. Alpine Road. Both properties are owned by Louis Capra & Associates. The variances will allow the owner to delay installation of sampling devices at the designated properties until August 1, 2022. Until that date, the owner will pay for the District to televise the service line on or about October 1, 2018 and October 1, 2020; seconded by Trustee Jones; motion passed upon roll call as follows:

Supporting Services Manager Reader provided status of activity regarding sewer main line cleaning, televising crews, pipe replacement, manhole ticket backlog breakdown and manhole restoration. Reader gave particular commendation to the televising crews and their supervision. Reader also reported that there were no mainline back-ups in July.

Business Manager Black reported user revenue fee was 5% under budget YTD in overall revenues. Total revenue is 1% under budget YTD. Operating expenses were almost equal to budget YTD, and income statement reflects \$2,280,746 in net operating income for July, 2018. Cash increased \$3,379,116 for the 2018-19 fiscal year. General fund cash total at the end of the month was \$26,044,400. Total number of authorized full-time positions is 116; 113 filled as of July 31. Vacant positions on July 31 were an Operations Supervisor and two Treatment Plant Operators. (Operations Supervisor began employment on August 27.)

Black distributed an updated Moody's bond rating published August 24, 2018. The District maintained its existing rating of Aa2, which is Moody's third-highest rating category.

President Massier announced that the regular session would now recess to enter into Meeting of the Committee of Local Improvements, then Closed Session to discuss pending litigation, 5 ILCS 120/2(c)(11).
