# ESSENTIAL FUNCTIONS (Illustrative Only)

Operates and monitors the performance of the equipment of the wastewater treatment system, such as pumps, electric boards, motor load switches, chemical feeds, gauges, etc., and maintains appropriate chemical levels for chemical dependent functions.

Ensures that plant operations are in compliance with operating guidelines and state and federal laws.

Checks all moving equipment such as motors for oil, grease, bearing overheating, malfunctions, and other problems.

Originates work order requests to identify malfunctioning equipment.

Checks and maintains appearance of building for cleanliness, heat control and other conditions.
