AD1-1 Notice

This **REVISED Addendum No. 1**, dated July 1, 2022, to the Invitation to Bid: **Final Clarifiers #7 & #8**, supersedes all contrary and conflicting information in the abovementioned instructions, specifications, and contract documents which are hereby supplemented or revised in certain particulars as follows:

AD1-2 General Information

The Authority submits **REVISED Addendum No. 1** to make clarifications and answer questions. The list of mandatory meeting attendees is included. **Disregard Addendum No. 1 dated June 30, 2022.**

AD1-3 Clarifications

- 1. The tank will be firehose clean, FRSA will dewater as needed.
- **2.** 7-10 days prior notice of when contractor will be onsite is required.
- 3. Notify FRSA if anything of any size, however small, drops into the tank.
- **4.** Clear sealer is required as an extra layer of protection on everything above the water line.
- **5.** The aluminum treads, handrails, and toe-kicks are to be removed and re-installed by contractor.
- **6.** Painting to be done to a depth of 18" below water line.
- **7.** Steel Immersion is to be white not Hazy Gray.
- **8.** The color of everything being painted should be white; motors, housings, catwalks, tubes. Everything that is currently white will be painted white.
- **9.** Nothing on the outer part of the clarifiers such as weirs will be painted.
- **10.** Paint around the conduit under catwalk.
- **11.** Exterior only of scum tube under catwalk shall be painted.
- **12.** Draining the clarifier takes 24 hours.
- **13.** If a piece of metal has deteriorated so badly it is destroyed during prep, FRSA will repair or replace.

AD1-4 Questions & Answers

Question 1: Are both tanks to be done?

Answer 1: Yes, one at a time.

Question 2: During blasting, is tarp cover needed?

Answer 2: Covering with tarp not necessary, anything in the tank will be reclaimed by FRSA. Open air blasting is acceptable.

Question 3: What is the diameter of the clarifiers?

Answer 3: 110 Feet.

Question 4: What should the mil thickness of the Sherwin Williams Steel Immersion Service coating be?

Answer 4: 12 mils when wet, will result in 8 mils dry per Sherwin Williams sales rep.
