This Addendum Number 2, dated January 20, 2023, for the above referenced project, supersedes all contrary and conflicting information in the specifications and contract documents, which are hereby supplemented or revised as follows:

I. General Information:

An optional informational meeting will be conducted virtually via Teams on Monday, January 30, 2023, from 2:00 pm to 3:00 pm US Central time, for the purpose of providing additional technical information related to the Aerobic Granular Sludge Equipment specified in Section 46 43 55 specific to the mechanical components and arrangement of these components. The meeting will provide additional details not available on the Drawings or in the Specifications and that is subject to confidentiality requirements from the Aerobic Granular Sludge Equipment Base Bid (Type III) supplier. Any such similar information required of any Bidder related to a substitute supplier shall be the responsibility of the Bidder to obtain. The meeting will not include any details of other components of the Aerobic Granular Sludge Equipment supply such as electrical or controls or any other project components. Any questions on these other components should be submitted to the Authority in accordance with the Bidding procedures. The conditions and procedures for participation in this meeting are as follows:

- The meeting will be conducted virtually via Teams. There will NOT be any meeting minutes issued for the meeting; it is the responsibility of potential Bidders to attend this meeting to receive the information presented in the meeting and to ask questions on the topic at this meeting. All additional supplementary information that is provided in the meeting will NOT be distributed via any other means. Meeting attendees must have audio and video (for screen sharing) capabilities to fully participate in the meeting. Attendees must have cameras enabled during the meeting. Time will be allotted for Bidders to ask questions during the meeting and responses will be provided at the meeting.
- All Bidders attending the meeting MUST execute a nondisclosure agreement (NDA) between the Bidder and the Base Bid Aerobic Granular Sludge Equipment supplier. Upon notice to the Authority as stated herein of intent to participate in the meeting, the NDA will be provided to the Bidder. If any representatives employed by a company other than the Bidder, a NDA must also be executed by such company.
- Bidders must provide notice to the Authority of intent to participate in the meeting and request the NDA for execution by no later than noon US Central time, Thursday, January 26, 2023. Notice/request shall be made via email to

agood@fourrivers.illinois.gov. When providing the NDA to the requester, the meeting connection information will also be provided to the Bidder.

- The executed NDA must be returned to the Authority via email at same address noted above by no later than 4:00 pm US Central time, Friday, January 27, 2023. When returning the executed NDA, the Bidder must also provide a listing of planned participants in the meeting, including name, company, email address, and phone number associated with the device/Teams account that the attendee will use to access the meeting. On the date and time of the meeting, only those persons requesting to join the meeting will be admitted to the meeting. Any persons attempting to connect to the meeting that cannot be identified against the information provided as noted herein will NOT be admitted to the meeting.
- The Team meeting connection will be active starting at five minutes prior to the meeting time. Any attendees not requesting admittance via connection to the meeting link by five minutes after the start of the meeting will NOT be admitted.

II. The following are revisions to the Specifications:

1. The following revision shall be made to Section 43 11 15 High Speed Gearless Turbo Blowers
 - a. Paragraph 2.2.B. REMOVE the abbreviation “hp” in the Guaranteed Package Wire-to Air Power column of the guarantee table and REPLACE with: “kW”.

III. The following are revisions to the Drawings:


1. Drawing 99-M-504, Sheet 150 of 163:
 - a. Add the following note to those associated with the table of estimated quantities of components on the drawing: “4. The quantities of components cited in the above tables are per single reactor of 4 total.”

This information shall be taken into consideration when preparing your bid. Bidders shall acknowledge all project addenda. This addendum will be emailed to all plan holders as well as posted to FRSA’s website at fourrivers.illinois.gov.
