

Article 1 — Notice to Bidders

The Four Rivers Sanitation Authority (FRSA) will receive signed and sealed bids for Capital Project No. 2425, Pump Station Roadway Replacement, at the Steve Graceffa Administration Building (Administration Building) at 3501 Kishwaukee Street, Rockford, Illinois until 10:30 a.m. on Tuesday, August 22, 2023, at which time and place responsive / responsible bids will be publicly opened and read aloud.

The Pump Station Roadway Replacement project consists of HMA pavement removal and replacement at multiple existing FRSA pump station sites. Work also includes earth excavation, installation of aggregate base course, concrete curb and gutter, turf restoration, and all other appurtenances indicated in the bid documents.

Bidder's attention is called to Article 2 – Instructions to Bidders 3.8 requirements for Statement of Qualifications. Bidder must have a permanent business office within forty (40) miles of FRSA's office at 3501 Kishwaukee Street in Rockford, Illinois.

All project work shall be completed by November 17, 2023. Liquidated damages shall be \$300.00 per calendar day.

Bid documents may be obtained at a cost of \$50.00 per set (non-refundable) by contacting the FRSA Engineering Department at 815-387-7660.

Plans and specifications may also be viewed at the offices of the Northern Illinois Building Contractors Association at 1111 S. Alpine Rd, Rockford, Illinois. For more information, visit the FRSA website at <u>fourrivers.illinois.gov</u>.

All construction shall be done in accordance with specifications on file with FRSA, including the *General Provisions and Technical Specifications for Sanitary Sewer Construction*, Four Rivers Sanitation Authority (Current Edition).

Each Proposal must be accompanied by the FRSA Bid Bond form with an acceptable Bid Security attached, in the amount of five percent (5%) of the total bid price. This amount is a guarantee that, if the Proposal is accepted, a Contract will be entered into and its performance properly secured.

The successful bidder will be required to furnish a satisfactory Performance Bond in the full amount of the Bid or Proposal. No Bid shall be withdrawn without FRSA's consent for a period of sixty (60) days after the scheduled closing time for receipt of bids.

FRSA reserves the right to reject any or all bids, or any part thereof, or to accept any bid or any part thereof, or to waive any formalities in any bids, deemed to be in the best interest of FRSA.

Article 2 — Instructions to Bidders

1 General

1.1 Scope and Intent

This section of the Contract Documents provides detailed information and requirements for preparing bids to prospective bidders, bidders' responsibility, the preparation and the submission of bids, basis for awarding the Contract and other general information concerned with bidding and executing the Contract.

1.2 Contradictions

If in the case of apparent contradictions between or among the Contract Documents, the Contract Documents shall be consulted in the following order: Addenda, Agreement, Supplementary Drawings, Instructions to Bidders, Detailed Specifications, Plans, Four Rivers Sanitation Authority (FRSA) General Provisions and Technical Specifications for Sanitary Sewer Construction. The language in the first such document in which language regarding the conflict, error or discrepancy occurs shall control.

1.3 Pre-Bid Meeting

A pre-bid meeting for this project will be held on Wednesday, August 16, 2023. The meeting will begin at 9:00 a.m. at the FRSA Gem Suburban Pump Station located at 3552 Aquamarine Drive, Rockford, IL (Item 1 on the overall location map provided in Section III of the Specifications). The purpose of the meeting is to allow each prospective bidder access to each site. Once the visit at the Gem Suburban Pump Station site is complete, FRSA staff will continue to each pump station site, progressing in the order sites are numbered on the overall location map provided in Section III of the Specifications. The pre-bid meeting is not mandatory.

2 Legal Requirements

2.1 Illinois Regulations

- A. Public Act 100-1177 (820 ILCS 130/) entitled the "Prevailing Wage Act" requires the Bidder to comply with prevailing wages in accordance with the Illinois Department of Labor Standards. The State of Illinois requires contractors and subcontractors on FRSA projects to submit certified payroll reports via the State's Certified Transcript of Payroll Portal currently found at: https://www2.illinois.gov/idol/Laws-Rules/CONMED/Pages/certifiedtranscriptofpayroll.aspx. The Bidder is responsible for verifying current information at the State's website.
- B. Public Act 83–1030 (30 ILCS 565/) entitled the "Steel Products Procurement Act" requires that steel products used or supplied in performance of this Contract or subcontract must be manufactured or produced in the United States with three exceptions.

The provisions of this Section shall not apply:

- 1. Where the Contract involves an expenditure of less than \$500.
- 2. Where the executive head of the public agency certifies in writing that

- a) the specified products are not manufactured or produced in the United States in sufficient quantities to meet the agency's requirements, or
- b) obtaining the specified products, manufactured or produced in the United States would increase the cost of the Contract by more than 10%.
- 3. When its application is not in the public interest.
- C. Public Act 96-929 (30 ILCS 570/) entitled the "Illinois Workers on Public Works Act' provides that Illinois residents be employed on Illinois public works projects, provided there has been a period of excessive unemployment (5%) in the State of Illinois as defined in the Act; and, further, that Illinois workers are available and capable of performing the particular type work involved.
- D. Public Act 101-0221 entitled the "Workplace Transparency Act" requires that any party to a contract adopt and promulgate written sexual harassment policies that include, as a minimum, the following information:
 - 1. the illegality of sexual harassment
 - 2. the definition of sexual harassment under Illinois State law
 - 3. a description of sexual harassment, utilizing examples
 - 4. my (our) organization's internal complaint process including penalties
 - 5. the legal recourse, investigative and complaint process available through the Illinois Department of Human Rights and the Illinois Human Rights Commission
 - 6. directions on how to contact the Department and the Commission
 - 7. protection against retaliation as provided by Section 6-101 of the Illinois Human Rights Act

Upon request, this information must be provided to the Illinois Department of Human Rights and the FRSA.

- E. With regard to nondiscrimination in employment, the Contractor for this project will be required to comply with the Illinois Fair Employment Practices Commission's Rules and Regulations.
- F. The Contractor for this project must comply with the Occupational Safety and Health Act.
- G. The Contractor for this project must comply with the Federal Drug-Free Workplace Act.
- H. Public Act 96-1416 requires the Certification of Clean Construction and Demolition Debris (CCDD) and uncontaminated soil prior to disposal at a CCDD fill site. The Contractor for this project must comply with Public Act 96-1416 and be responsible for the certifications and any fees associated with the disposal at a CCDD fill site.
 - In the event that contaminated soil is uncovered on the project, the Contractor must notify FRSA immediately. Any extra costs resulting from the presence of contaminated soil must be evaluated in accordance with FRSA General Provisions & Technical Specs for Sanitary Sewer Construction; General Conditions: Article 5

 – Time Provisions and Article 8 – Changes.

2.2 Americans with Disabilities Act

The Contractor for this project will comply with all applicable requirements of the Americans with Disabilities Act of 1990 (ADA). The Contractor will hold harmless and indemnify Four Rivers Sanitation Authority (FRSA) and their representatives from all:

- B. costs, either for defense (including but not limited to reasonable attorney's fees and experwitness fees) or for settlement
- C. damages of any kind (including but not limited to actual, punitive, and compensatory damages)

relating in any way to or arising out of the ADA, to which said firm is exposed or which it incurs in the execution of the Contract.

3 General Instructions

3.1 Bidder's Responsibility

Bidders are cautioned not to submit proposals until having carefully examined the entire site of the proposed work and adjacent premises and the various means of approach and access to the site, and having made all necessary investigations to inform themselves thoroughly as to the facilities for delivering, placing and handling the materials at the site, and having informed themselves thoroughly as to all difficulties involved in the completion of all the work under this Contract in accordance with its requirements.

Bidders must examine the Plans, Specifications and other Contract Documents and shall exercise their own judgment as to the nature and amount of the whole of the work to be done and for the bid prices must assume all risk of variance, by whomsoever made, in any computation or statement of amount or quantities necessary to complete fully the work in strict compliance with the Contract Documents. The Bidder must satisfy himself by making borings or test pits, or by such methods as he may prefer, as to the character and location of the materials to be encountered or work to be performed. No pleas of ignorance of conditions that exist or that may hereafter exist, or of conditions or difficulties that may be encountered in the execution of the work under this Contract, as a result of failure to make the necessary examinations and investigations, will be accepted as an excuse for any failure or omission on the part of the Contractor to fulfill, in every detail, all of the requirements of the Contract Documents, or will be accepted as a basis for any claims whatsoever for extra compensation or for an extension of time.

The Contractor is responsible for verifying the location of all existing utilities in the project areas.

The Bidder, therefore, shall satisfy himself by such means as he may deem proper as to the location of all structures that may be encountered in construction of the work.

3.2 Addenda and Interpretations

No interpretation of the meaning of the Plans, Specifications, or other Contract Documents will be made to any bidder orally. Every request for such interpretation must be in writing addressed to Four Rivers Sanitation Authority, 3501 Kishwaukee Street, Rockford, Illinois.

To be given consideration, such request must be received at least five (5) days prior to the date fixed for the opening of bids. Any and all such interpretations and any supplemental instructions will be in the form of written addenda which, if issued, will be sent by email, fax, or certified mail with acknowledgement of receipt requested, to all prospective bidders, at the respective addresses furnished for such purposes, not later than three (3) days prior to the date fixed for the opening of bids. Failure of any bidder to receive any such addenda or interpretation shall not relieve said bidder from any obligation under his bid as submitted. All addenda so issued shall become part of the Contract Documents.

3.3 Laws and Regulations

The prospective bidder is warned that he must comply with all laws of the United States Government, State of Illinois, all ordinances and regulations of FRSA in the performance of the work under this Contract. The Bidder's attention is specifically called to that provision of the General Conditions regarding the rate of wage to be paid on the work.

3.4 Quantities Estimated Only

Bidders are warned that the estimate of quantities of the various items of work and materials, as set forth in the Proposal form, is approximate only and is given solely to be used as a uniform basis for the comparison of bids. The quantities actually required to complete the Contract work may be less or more than so estimated, and if awarded a contract for the work specified, the Contractor further agrees that he will not make any claim for damages or for loss of profits or for an extension of time because of a difference between the quantities of the various classes of work assumed for comparison of bids and quantities of work actually performed.

3.5 Form, Preparation, and Presentation of Proposals

For particulars as to the quantity and quality of the supplies, materials and equipment to be furnished, and the nature and extent of the work or labor to be done, prospective bidders are referred to the Contract Documents, which may be examined or obtained at the office of FRSA.

Each bid will be submitted upon the prescribed Proposal form. All blank spaces for bid prices must be filled in, in ink, with the unit or total sum or both for which the Proposal is made. If the Proposal contains any omissions, erasures, alterations, additions or items not called for in the itemized Proposal, or contains irregularities of any kind, such may constitute sufficient cause for rejection of bid. In case of any discrepancy in the unit price or amount bid for any item in the Proposal, the unit price as expressed in figures will govern. In no case is the agreement form to be filled out or signed by the bidder.

Bidders may opt to contact FRSA's Engineering Department at 815.387.7660 to obtain an electronic Proposal form. If used, this form must be attached to the hard copy Proposal form and appropriately signed and executed with the bid.

The bid must be verified and be presented on the prescribed form in a sealed envelope on or before the time and at the place stated in the Advertisement for Bids, endorsed with the name of the person, firm or corporation presenting it, the date of presentation, and the title of the work for which the bid is made. If forwarded by mail, the sealed envelope containing the Proposal and marked as directed above, must be enclosed in another envelope addressed to

Clerk of the Four Rivers Sanitation Authority, 3501 Kishwaukee Street, Rockford, Illinois, 61109 and be sent preferably by certified mail. FRSA will not accept facsimile generated bids.

3.6 Bid Security

Each Proposal must be accompanied by the FRSA Bid Bond form with an acceptable Bid Security attached, in the amount specified in Article One, Notice to Bidders. This sum is a guarantee that, if the Proposal is accepted, a contract will be entered into and its performance properly secured. The FRSA's Bid Bond Form included in the bid packet must be used. No other Bid Bond form may be substituted.

Within ten (10) days after the opening of bids, the deposits of all but the three lowest bidders will be returned. The deposits of the remaining two unsuccessful bidders will be returned within three (3) days after the execution of the Contract, or, if no such Contract has been executed, within sixty (60) days after the date of opening bids. The deposit of the successful bidder will be returned only after he has duly executed the Contract and furnished the required bond and insurance.

3.7 Affidavit of Compliance

Each proposal must be accompanied by an executed Affidavit of Compliance. A separate Affidavit of Compliance form is enclosed with the Proposal packet. Failure to submit an executed Affidavit of Compliance with the Proposal may constitute sufficient cause for rejection of the bid.

3.8 Statement of Qualifications

Each Proposal must be accompanied by a Statement of Qualifications certifying that the bidder is registered to do business in the State of Illinois, has a permanent business office within forty (40) miles of the FRSA office at 3501 Kishwaukee Street in Rockford, IL, and provides documentation that the bidder possesses the appropriate financial, material, equipment, facility and personnel resources and expertise necessary to meet all contractual obligations. The bidder shall document no less than three (3) contracts for hot-mix asphalt (HMA) paving work within the past five (5) years having equal or greater value to the bid being submitted. FRSA reserves the right to request additional information, as needed, to evaluate bids prior to making an award.

3.9 Comparison of Proposals

Bids on item contracts will be compared on the basis of a total computed price arrived at by taking the sum of the estimated quantities of each item, multiplied by the corresponding unit prices and including any lump sum bids on individual items, in accordance with the estimate of quantities set forth in the Proposal form. Bids on lump sum contracts will be considered upon the basis of the lowest sum bid.

3.10 Acceptance of Bids and Basis of Award

The contract will be award, if at all, to the lowest responsive, responsible bidder. No bidder may withdraw his bid after the scheduled closing time for receipt of bids, for at least sixty (60) days. Four Rivers Sanitation Authority also reserves the right to reject any of all bids.

The bidder whose proposal is accepted will be issued a Notice of Award by the FRSA Executive Director. Within ten (10) days of issuance of the Notice of Award, the successful bidder shall enter into a written contract for the performance of the Proposal work and shall

furnish the required bonds and insurance certificates upon being served such Notice, personally, by mailing, or via email.

If the bidder does not comply with the Notice of Award, FRSA will issue a Deficiency Notice. If the bidder to whom the contract is awarded refuses or neglects to execute it or fails to furnish the required bond and insurance within five (5) days after receipt by him of Deficiency Notice, the amount of his deposit shall be forfeited and shall be retained by FRSA as liquidated damage and not as a penalty. It being now agreed that said sum is a fair estimate of the amount of damages that FRSA will sustain in case said bidder fails to enter into a contract and furnish the required bond and insurance. No plea of mistake in the bid shall be available to the bidder for the recovery of his deposit or as a defense to any action based upon the neglect or refusal to execute a contract.

3.10.1 Evaluation of Responsiveness

The responsiveness of bidders will be judged on the basis of the completeness of the bid submitted. To be responsive, a Bid must be submitted on the forms provided as part of the Bid Documents and comply with all the requirements of the Instruction to Bidders.

3.10.2 Evaluation of Responsibility

To be judged as responsible, the bidder shall:

- A. Have adequate financial resources for performance, the necessary experience, organization, technical qualifications, and facilities, or a firm commitment to obtain such by subcontracts:
- B. Be able to comply with the required completion schedule for the project;
- C. Have a satisfactory record of integrity, judgment, and performance, including, in particular, any prior performance on contracts from FRSA;
- D. Have an adequate financial management system and audit procedures, that provide efficient and effective accountability and control of all property, funds, and assets;
- E. Conform to the civil rights, equal employment opportunity and labor law requirements of the Bid Documents.
- F. Have satisfactorily completed no less than three (3) hot-mix asphalt (HMA) paving contracts within the past five (5) years of equal or greater value to the bid being submitted.

3.11 The Rejection of Bids

FRSA reserves the right to reject any bid if the evidence submitted in the statement of the bidder's qualifications, or if investigation of such bidder fails to satisfy FRSA that such bidder is properly qualified to carry out the obligations and to complete the work contemplated therein. Any or all proposals will be rejected if there is reason to believe that collusion exists among the bidders. Conditional bids will not be accepted. FRSA reserves the right to reject any and all bids and to accept the bid which they deem most favorable to the interest of FRSA after all Proposals have been examined and canvassed.

3.12 Insurance and Bonding

Contractor shall provide all necessary insurance and bonds required to complete the project. No more than ten (10) calendar days subsequent to FRSA's issuance of an award letter, the

Contractor shall provide documentation to prove that he has obtained all required insurance and bonds. FRSA shall be the sole judge as to the acceptability of any such proof.

Contractor shall provide and maintain all insurance and bonds as required by FRSA.

3.12.1 General

The Contractor shall ensure that:

- A. All insurance policies shall be specific to the project.
- Ses B. The insurance certificate shall state: This certifies that the insurance coverage meets of exceeds that required for Pump Station Roadway Replacement, Capital Project No. 2425.
- C. FRSA shall be named as Additional Insured in all policies; this shall include the Owners' Contractors' Protective Policy option.
- D. All completed operations coverages and bonds shall remain in force for a period of two (2) years following acceptance of the Project and completed operations shall stay in force for two (2) years following completion of the Project.

3.12.2 Insurance

Bid Doc. No. 23-411

The Contractor shall, for the duration of the Contract and for two (2) years following project acceptance, maintain the following:

- A. General Liability: \$1,000,000 combined single limit per occurrence for bodily injury, personal injury and property damage. If Commercial General Liability Insurance or other form with a general aggregate limit is used, either the general aggregate limit shall apply separately to this project or the general aggregate limit shall be twice the required occurrence limit. The Contractor shall provide "XCU" coverage.
- B. Automobile Liability: \$1,000,000 combined single limit per accident for bodily injury and property damage including coverages for owned, hired or non-owned vehicles, as applicable.
- C. Workers' Compensation and Employers Liability: Workers' Compensation limits as required by statute and Employers Liability limits of \$500,000 per accident and \$500,000 per disease.
- D. <u>Umbrella</u>: \$2,000,000 per occurrence/aggregate for contracts valued at \$500,000 or over, or \$1,000,000 for contracts below \$500,000. \$10,000 is maximum allowable selfretained limit.
- E. Errors and Omissions: If the Contractor performs professional services, he shall maintain errors and omissions insurance with a limit no lower than \$1,000,000 for the duration of the contract.

The policies shall contain, or be endorsed to contain, the following provisions in the General Liability and Automobile Liability Coverage's:

1. Unless otherwise provided in paragraph "c" of this section, FRSA, its officers, officials, employees and volunteers shall be covered as additional insureds as respects liability arising out of activities performed by or on insured's general supervision of the Contractor, products and completed operations of the Contractor, premises owned, occupied or used by the Contractor, or automobiles owned, leased, hired or borrowed

- by the Contractor. The coverage shall contain no special limitations on the scope of protection afforded to FRSA, its officers, officials, employees, volunteers, or agents.
- 2. Unless otherwise provided in paragraph "c" of this section, the Contractor's insurance coverage shall be primary insurance as respects FRSA, its officers, officials, employees, volunteers, and agents. Any insurance or self-insurance maintained by FRSA, its officers, officials, employees, volunteers, or agents shall be excess of the Contractor's insurance and shall not contribute with it.
- 3. As an acceptable alternative to provisions "a" and "b" of this section, the Contractor may provide owner's and contractor's protective liability insurance with coverage limits, named insureds, and in conformity with all applicable specifications of this section.
- 4. Any failure to comply with reporting provisions of the policies shall not affect coverage provided to FRSA, its officers, officials, employees, volunteers, or agents.
- 5. The Contractor's insurance shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the limits of the insurer's liability.
- 6. All Coverages Each insurance policy required by this clause shall not be suspended, voided, canceled by either party, reduced in coverage, or in limits except after thirty (30) days' prior written notice by certified mail, return receipt requested, has been given to FRSA.

3.12.3 Best's Ratings

FRSA shall be the sole judge of whether or not said insurer's ratios are satisfactory. FRSA 's decision shall be final and FRSA 's bidding procedures contain no appeal provision.

- A. <u>Alphabetical Rating</u>: For purposes of this Request for Bids, "insurer" shall mean any surety, insurance carrier, or other organization which proposes to provide an insurance policy or bond for the Contractor. No insurer or surety rated lower than "A-, Excellent" in the current *Best's Key Rating Guide* shall be acceptable to FRSA.
- B. <u>Financial Size Rating</u>: Provided an insurer's alphabetical rating is satisfactory, FRSA will examine said insurer's financial size rating.
 - 1. If Best classifies the insurer XII or larger, said insurer shall be acceptable to FRSA.
 - 2. If <u>Best</u> classifies the insurer as smaller than XII, but larger than VI, said insurer shall be submitted to FRSA's Director of Management Services and/or FRSA's insurance consultant for review.

Financial Size ratings less than VII are not acceptable and will disqualify the Contractor.

3.12.4 Performance Bond and Labor & Materials Payment Bond Form

The Contractor shall provide a Performance Bond and Labor & Materials Payment Bond form acceptable to FRSA. The performance bond shall be for either 100% of the contract price or for the Contractor's unit price times the estimated number of units, as applicable.

This Request for Bids contains a Performance Bond and a Labor & Material Bond form for the Contractor's use.

If the Contractor fails to provide acceptable bonds within the specified time, he shall be in default.

3.12.5 Correction of Contractor's Insurance or Bond Deficiencies

If FRSA determines that the Contractor's insurance or bond documentation does not conform to these specifications, FRSA shall inform said Contractor of the non-conformity. If said Contractor fails to provide conforming insurance or bond documentation within five (5) calendar days of FRSA's deficiency notice, he shall be in default.

3.12.6 Indemnification Clause

Contractor shall protect, indemnify, hold and save harmless and defend FRSA, its officers, officials, employees, volunteers, and agents against any and all claims, costs, causes, actions and expenses, including but not limited to attorney's fees incurred by reason of a lawsuit or claim for compensation arising in favor of any person, including the employees, officers, independent contractors, or subcontractors of the Contractor or FRSA, on account of personal injuries or death, or damages to property occurring, growing out of, incident to, or resulting directly or indirectly from the performance by the Contractor or subcontractor, whether such loss, damage, injury or liability is contributed to by the negligence of FRSA or by premises themselves or any equipment thereon whether latent or patent, or from other causes whatsoever, except that the successful bidder shall have no liability for damages or the costs incident thereto caused by the sole negligence of FRSA.

The indemnification shall not be limited by a limitation on amount or type of damages payable by or for the Contractor or its subcontractor under any employee benefits act including, but not limited, to the Workers Compensation Act.

No inspection by FRSA, its employees, or agents shall be deemed a waiver by FRSA of full compliance with the requirements of the Contract. This indemnification shall not be limited by the required minimum insurance coverages in the Contract.

3.13 Tax Exemption

FRSA is exempt, by law, from paying bidder Federal Excise Tax and Illinois Retailers' Occupational Tax. Therefore, the bidder shall exclude those taxes from his bid. FRSA's tax exemption number is E9992-3696-06. The bidder shall include all other applicable taxes in his bid price.

Article 3 – Detailed Specifications

1 General

1.1 General

This article contains detailed specifications related to Proposal items. The work to be done under each item is discussed along with units for payment and measurement for payment. However, the descriptions given do not necessarily outline all the work to be done under any item. All work shall conform to current editions of the *Standard Specifications for Water and Sewer Main Construction in Illinois, Four Rivers Sanitation Authority (FRSA) General Provisions and Technical Specifications for Sanitary Sewer Construction,* and the *Illinois Department of Transportation's* (IDOT's) *Standard Specifications for Road and Bridge Construction.*

Throughout these specifications, the term "Owner" and "FRSA" shall be synonymous.

In case of apparent contradictions between *Article 3 - Detailed Specifications*, *IDOT Standard Specifications*, and *General Provisions and Technical Specifications for Sanitary Sewer Construction*, *Article 3 - Detailed Specifications* shall govern.

Any utility locations shown on the plans are based on records of unknown reliability and, therefore, are not guaranteed. The orientation and location (horizontal and vertical) of all existing underground utilities, such as gas mains, water mains, electric lines, field tiles, irrigation pipes, etc., shall be ascertained by the Contractor. The Contractor shall assume full responsibility for all utility locations.

The general location of the proposed work is outlined on the plans. Minor variations in alignment may be made to facilitate construction operations with prior FRSA approval.

Any construction not supervised by a FRSA Inspector will not be accepted.

In accordance with G.C. 12:1 of FRSA's *General Provisions and Technical Specifications for Sanitary Sewer Construction*, any damage caused by the Contractor's operations to areas outside of the specified project limits, including but not limited to roadway pavements, driveway pavements, drainage structures, storm sewer, underground utilities, overhead utilities, turf areas, cultivated areas, and landscaped areas shall be repaired and/or replaced by the Contractor at no additional cost to the Contract.

No work shall be permitted on Sundays or FRSA Holidays without prior approval by the FRSA Director of Engineering.

FRSA will not supervise, direct, control, have authority over or be responsible for the Contractor's means, methods, techniques, sequences, procedures of construction, safety precautions and programs incident thereto, or for any failure by the Contractor to comply with all applicable laws and regulations in performance of the specified work. FRSA shall not be responsible for the Contractor's failure to perform or furnish the work in accordance with the Contract documents.

2 Notification, Access, and Special Considerations

2.1 Notification

The Contractor's proposed sequence of work shall be outlined in the Project Schedule and shall be submitted to FRSA prior to beginning any work.

The Contractor shall notify the FRSA Survey & Field Operations Manager, Ben Christiansen, at (815)209-7952 forty-eight (48) hours minimum prior to performing any work.

2.2 Access

The FRSA will provide the Contractor with one (1) key that will open the exterior gate of each pump station site. The Contractor shall return the provided key prior to the FRSA's final acceptance and payment of the Contract.

2.3 Special Considerations

The FRSA has a separate contract for removal of the perimeter fence at Site #8, University Center Pump Station. Coordinate the schedule for Site #8 with the FRSA Project Manager to ensure the fence is removed prior to beginning work. The existing fence posts will remain in place, only the fence panels will be removed.

2.4 Submittals

No separate payment will be made for costs associated with notification, access, and special considerations.

4 Pavement Removal

4.1 General

This work shall be done in accordance with Section 440 of the *IDOT Standard Specifications* and shall involve the complete removal and disposal of the existing pavement sections where indicated on the plans, including variable depths and pavement types (including hot-mix asphalt and concrete). The Contractor shall not remove any pavement outside of the limits shown on the plans without prior written approval from the FRSA. Any damage done to pavements beyond these limits shall be replaced full depth by the Contractor at no additional cost to the FRSA.

The pavement limits shall be sawcut full depth prior to removal. The remaining pavement surfaces and edges shall be protected from all damage. All costs associated with saw cutting and pavement protection shall be included in this pay item.

All pavements shall be removed from the site in accordance with all applicable State or Federal laws and regulations. Clean Construction or Demolition Debris regulations shall be adhered to by the Contractor in the disposal of all pavements removed from the site.

Ses Payment shall be made at the Contract unit price per square yard (SY) of Pavement Removal.

Earth Excavation 5

5.1 General

This work shall be done in accordance with Section 202 of the IDOT Standard Specifications and shall include the excavation and transportation of all suitable excavated materials to various locations throughout the project site, and/or the excavation, transportation, and off-site disposal of excavated material. For the purposes of this pay item, earth excavation shall include all excavated materials (topsoil, subsurface soils, aggregate base course, etc.) to properly construct the project to the lines and grades shown on the plans. Pavements scheduled for removal on the plans shall be paid for separately as indicated in the preceding section.

Unsuitable material that is encountered shall be removed from the site.

5.4 Payment

Payment shall be made at the Contract unit price per square yard (SY) of Earth Excavation at the specified depth.

Aggregate Base Course, Type B 6

6.1 General

This work shall consist of placing and compacting aggregate base course, Type B to the depths indicated on the plans, and shall include subgrade preparation, removal and disposal of excess material, furnishing, placing, installing and compacting course aggregate, and trimming and prepping aggregate base for subsequent pavement placement as required at the individual site locations. All work shall be in accordance with Section 351 of *IDOT Standard Specifications*.

6.2 Materials

Aggregate base course shall be placed to the depths as indicated for each site. Where a 10" compacted depth is specified, the bottom 6" layer shall be Gradation CA-2 and the upper 4" layer shall be Gradation CA-6. Course aggregates shall be in accordance with Article 1004.04 of the *IDOT Standard Specifications*. Crushed concrete materials approved by IDOT and in accordance with Article 1004.04 may be allowed in lieu of quarried materials, subject to prior FRSA approval.

Existing on-site base course aggregates may be re-used, if approved by the FRSA Inspector.

6.3 Required Submittals

A. Material gradation certifications for aggregates

6.4 Payment

This work will be paid for at the Contract unit price per ton (TON) for Aggregate Base Course, Type B, of the specified gradation, compacted in place.

7 Hot-Mix Asphalt Binder Course, IL-19.0, N50

7.1 General

This work shall be in accordance with T.S. 4.3/Pavement Restoration of the *General Provisions and Technical Specifications for Sanitary Sewer Construction in the Sanitary District of Rockford*, and Section 406 of the *IDOT Standard Specifications*, and shall be performed to the satisfaction of the FRSA.

Prime coat shall be MC-30 or PEP bituminous materials; all costs associated with furnishing and placing the prime coat shall be included in this pay item and no separate payment will be made.

The Contractor shall verify that the proposed Curb and Gutter has reached a minimum strength of 3500 PSI prior to placement of the adjacent HMA Binder Course.

7.2 Materials

HMA Binder Course shall be mixture IL-19.0, N50 in accordance with Section 1030 of the *IDOT Standard Specifications.*

Prime coat shall be MC-30 or PEP in accordance with Section 1032 of the IDOT *Standard Specifications*.

7.3 Required Submittals

- A. HMA Mix Designs
- B. Prime Coat material certifications

7.4 Payment

This work will be paid for at the Contract unit price per square yard (SY) for Hot-Mix Asphalt Binder Course, IL-19.0, N50 placed.

8 Hot-Mix Asphalt Surface Course, IL-9.5, Mix "C", N50

8.1 General

This work shall be in accordance with T.S. 4:3/Pavement Restoration of the *General Provisions and Technical Specifications for Sanitary Sewer Construction in the Sanitary District of Rockford*, and Section 406 of the *IDOT Standard Specifications*, and shall be performed to the satisfaction of the FRSA.

Tack coat shall be SS-1 bituminous materials; all costs associated with placement of the tack coat shall be considered incidental to this pay item and no separate payment will be made.

8.2 Materials

HMA Surface Course shall be IL-9.5, Mix "C", N50 in accordance with Section 1030 of the *IDOT Standard Specifications.*

Prime coat shall be SS-1 in accordance with Section 1032 of the IDOT *Standard Specifications*.

8.3 Required Submittals

- A. HMA Mix Designs
- B. Tack Coat material certifications

8.4 Payment

This work will be paid for at the Contract unit price per square yard (SY) for Hot-Mix Asphalt Surface Course, IL-9.5, Mix "C", N50 placed.

9 PCC Driveway Pavement, 8"

9.1 General

This work shall conform to Section 423 of the *IDOT Standard Specifications*. The existing subgrade shall be prepared and compacted prior to placement of the driveway pavement.

Expansion joints shall be installed per Article 423.07 of the IDOT Standard Specifications.

All excavation and preparation of base material shall be incidental to pavement installation.

9.2 Materials

Portland cement concrete mix shall be Class SI per Article 1020.04 of the *IDOT Standard Specifications*.

Expansion Joint Fillers shall be in accordance with Section 1051 of the *IDOT Standard Specifications*.

9.3 Required Submittals

A. PCC Mix Designs

B. Expansion Joint Fillers material certification

9.4 Payment

OSec This work will be paid for at the Contract unit price per square yard (SY) for PCC Driveway Pavement, 8", complete in place.

PCC Curb & Gutter 10

10.1 General

This work shall conform to Section 606 of the *IDOT Standard Specifications* and consist of installation of concrete curb and gutter as shown on the plans. Curb and gutter shall include "spill-out" and "depressed" sections at the locations indicated on the plans. For payment purposes, all concrete curb and gutter sections will be regarded as the same type - no separate payment will be made for standard, spill-out, or depressed curb and gutter types.

When replacing existing curb and gutter, existing curb shall be removed in accordance with Section 440 of IDOT Standard Specifications. Existing curb to be removed shall be saw-cut full depth at the limits of removal. New curb and gutter shall be doweled to existing curb with two (2) 1"diameter x 18" long dowel bars.

10.2 Materials

Portland cement concrete mix shall be Class SI per Article 1020.04 of the IDOT Standard Specifications.

10.3 Required Submittals

A. PCC mix designs

10.4 Payment

New PCC Curb & Gutter: Payment shall be made at the Contract unit price per linear foot (LF) of Concrete Curb & Gutter, irrespective of type.

Replacement Curb & Gutter: Payment shall be made at the Contract unit price per linear foot of Remove & Replace PCC Curb & Gutter, irrespective of type.

Furnish and Place Topsoil, 4" 11

11.1 General

This work shall conform to Section 211 of the IDOT Standard Specifications and consist of furnishing topsoil from an offsite source, placing the topsoil where specified on the location maps in Section III. Placed topsoil shall be shaped, trimmed and finished according to Section 212 of the IDOT Standard Specifications.

Finished thickness of placed topsoil shall be 4".

11.2 Materials

Topsoil obtained from off-site sources shall be in accordance with Article 1081.05(a) of the IDOT Standard Specifications.

11.3 Payment

Oses Payment will be made at the Contract unit price per square yard (SY) of Furnish and Place Topsoil, 4".

12 Restoration and Seeding

12.1 General

All turf areas disturbed in construction shall be restored. Restoration shall include filling any ruts, grading disturbed areas, seeding and fertilizer application and erosion control blanket installation.

12.2 Seeding and Fertilizing

The Contractor shall make certain that all disturbed areas have the same depth and quality of approved topsoil at the surface as existed prior to construction.

The seeding mixture used shall be compatible with the existing ground cover and shall be acceptable to the FRSA. Maintainable lawn areas shall be seeded with IDOT Class I seeding mixture. Existing non-maintained turf areas shall be seeded with IDOT Class 3-slope mixture.

Seedbed preparation shall be done according to Article 250.05 IDOT Standard Specifications.

Seeding methods shall be per Article 250.06

Fertilizer work shall be done in accordance with Article 250.04. Fertilizer shall have an analysis of 10-10-10.

Straw mulch shall be per Method 2 and done in accordance with the applicable portions of Section 251 of the IDOT Standard Specifications.

All seeded areas shall be maintained for at least thirty (30) days after application. Scattered bare spots no larger than two square feet will be allowed up to a maximum of five percent (5%) of any seeded area. Restoration shall be guaranteed by the Contractor for a period of one (1) year following final acceptance of the work.

At the direction of the FRSA or other governing agency, the Contractor shall provide steep slope protection over turf areas disturbed by construction in accordance with Sections 251.03 and 251.04 of IDOT Standard Specifications.

12.3 Erosion Control Blanket

Erosion control blanket shall be installed on all seeded areas throughout the project limits.

Installation of erosion control blanket shall be in accordance with Article 251.04 of the IDOT Standard Specifications and shall be installed on seeded areas within twenty-four (24) hours of seed placement.

12.4 Materials

Seeding mixture shall be Class 1 in accordance with the IDOT *Standard Specifications*.

Fertilizer shall have 270 lbs. of nutrients per acre with an analysis of 10-10-10 and shall be in accordance with Article 1081.08 of the IDOT Standard Specifications.

Seç All erosion control blanket shall be in accordance with Article 1081.10(a) and/or Article 1081.10(c) of the *IDOT Standard Specifications*.

12.4 Submittals

- 1. Seed mixtures and fertilizer specifications.
- 2. Material certification for erosion control blanket.

12.5 Payment

Payment for restoration and seeding shall be made at the Contract lump sum (LS) price for Restoration and Seeding for each individual site.

Traffic Control and Protection 13

13.1 General

The Contractor shall be solely responsible for the safety of all work operations, and shall comply with all State, local and OSHA regulations. Contractor shall retain a person competent in complying with OSHA trenching and excavation requirements on site at all times. The person shall be capable of identifying existing and potential hazards in the surroundings, or working conditions which are unsanitary, hazardous or dangerous to employees, and shall be authorized to take prompt corrective measures to eliminate them. The methods and means to comply with construction site safety are the sole responsibility of the Contractor. FRSA staff is not responsible for the Contractor's compliance procedures.

All work zone traffic control and protection shall be in compliance with the *Manual on Uniform Traffic Control Devices*, current edition.

13.2 Payment


No separate payment will be made for traffic control and protection. All costs associated with this work shall be incidental to the Contract.

14.1 General

Upon completion of work, the Contractor shall clean up and remove all construction debris, materials, equipment, machines, temporary concrete washouts etc., from the entire project area. All excavations shall be backfilled neatly to original grade, and any excess materials shall be hauled away to a site acceptable to the FRSA. All roadway surfaces shall be kept free and clear of all mud and construction debris.

If the Contractor shall fail to repair, replace, rebuild or restore such defective or damaged work promptly after receiving notice given by FRSA, the FRSA shall have the right to have the work done by others and to call on the Contractor and his bondsman to pay the costs thereof.

6. Contract Execution

IT IS EXPRESSLY UNDERSTOOD AND AGREED that the entire improvement shall be done in a thorough and workmanlike manner, under the direction and to the satisfaction of FRSA and in full compliance with all the requirements of its representative under them. All loss or damage arising out of the nature of the work to be done, or from any detention of unforeseen obstruction or difficulty which may be encountered in the prosecution of the work, or from the action of the elements, shall be sustained by the Contractor.

The Contractor will be held responsible for all accidents, and hereby agrees to indemnify and protect FRSA from all suits, claims, and actions brought against it, and all cost, and damages which FRSA may be put to by reason of an injury or alleged injury, to the person or property of another in the execution of this contract, or the performance of the work, or in guarding the same, or for any material used in its prosecution or in its construction.

Any person employed on the work who shall refuse or neglect to obey the directions of FRSA or its representative, or who shall be deemed by FRSA to be incompetent, or who shall be guilty of any disorderly conduct, or who shall commit any trespass on any public or private property in the vicinity of the work, shall at once be removed from the work by the Contractor when so requested by FRSA.

Any request to extend the contract completion date must be considered by the Board at the Board meeting prior to the then-existing contract termination date. Any deviation from this action will result in the liquidated damage clause in the contract to be exercised.

7. Payments to Contractor

FRSA hereby covenants and agrees, in consideration of the covenants and agreements in this Contract, specified to be kept and performed by the Contractor and subject to the conditions herein contained, and if FRSA receives an acceptable invoice prior to the tenth day of the month and receives approval of the work by the FRSA's Director of Engineering, FRSA shall issue payment before the fifth day of the succeeding month. If FRSA receives an acceptable invoice on or after the tenth day of the month, FRSA shall issue payment before the fifth day of the second succeeding month.

FRSA reserves the right at all times to refuse to issue payment in case the Contractor has neglected or failed to pay any subcontractors, workmen or employee on the work.

8. Subcontracts

No part of the work herein provided for shall be sublet or subcontracted without the express consent of FRSA, to be entered in the records, and in no case shall consent relieve the Contractor from the obligation herein entered into, or change the terms of this Agreement.

9. Contractor's Responsibility

This Contract shall extend to and be binding upon the successors and assigns, and upon the heirs, administrators, executors, and legal representatives of the Contractor.

In consideration of and to induce the award of this Contract to him, the Contractor represents and warrants: that he is not in arrears to FRSA upon debt of the Contract and that he is not a defaulter, as surety, contractor or otherwise; that he is financially solvent and sufficiently experienced and competent to perform the work; that the work can be performed as called for by the Contract; that the facts stated in his proposal and the information given by him is true and correct in all respects, and that he is fully informed regarding all the conditions affecting the work to be done and labor and materials to be furnished for the completion of this Contract and that his information was secured by personal investigation and research.

The Contractor shall pay not less than the prevailing wage rate as determined by the Department of Labor, to all laborers, workmen and mechanics performing work under this Contract. Contractor shall comply with current revisions of the wage standards; as required by law. The Contractor shall be responsible for verifying the prevailing wages each month and notifying all subcontractors of the appropriate monthly rates. The State of Illinois requires contractors and subcontractors on FRSA projects to submit certified payroll reports via the State's Certified Transcript of Payroll Portal currently found at: https://www2.illinois.gov/idol/Laws_Rules/CONMED/Pages/certifiedtranscriptofpayroll.aspx. The Contractor is responsible for verifying current website.

In regard to nondiscrimination in employment, Contractor will be required to comply with the Illinois Fair Employment Practices Commission's Rules and Regulations as provided herein.

The Contractor shall comply with the American Disabilities Act of 1990 (ADA). The Contractor will hold harmless and indemnify FRSA and their representatives from all:

- (a) suits, claims, or actions;
- (b) costs, either for defense (including but not limited to reasonable attorney's fees and expert witness fees) or for settlement, and;
- (c) damages of any kind (including but not limited to actual, punitive, and compensatory damages)

relating in any way to or arising out of the ADA, to which said firm is exposed or which it incurs in the execution of the contract.

- (a) the illegality of sexual harassment

The Contractor shall comply with Public Act 96-929 (30 ILCS 570) which provides that Illinois residents be employed on Illinois public works projects, provided there has been a period of excessive unemployment (5%) in the State of Illinois as defined in the Act; and further, that Illinois workers are available and capable of performing the particular type work involved.

The Contractor shall comply with all rules and regulations of OSHA during the execution of this Contract.

The Contractor shall comply with the Federal Drug Free Workplace Act.

The Steel Products Procurement Act, Illinois Public Act 83-1030, requires that steel products used or supplied in performance of this Contract or subcontract shall be manufactured or produced in the United States with three exceptions, as explained in the Instructions to Bidders.

The Contractor shall comply with Public Act 96-1416 regarding the disposal of CCDD and uncontaminated soil at CCDD fill sites as explained in the Instructions to Bidders.

10. Time

Work under this Agreement shall be commenced upon written Notice to Proceed. The completion date for this project shall be <u>November 17, 2023</u>.

11. Liquidated Damages

The amount of liquidated damages shall be \$300.00 per calendar day.

12. Counterparts

This Agreement may be executed and recorded in counterparts, each of which shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument. The Parties hereby acknowledge and agree that facsimile signatures or signatures transmitted by electronic mail in so-called "pdf" format shall be legal and binding and shall have the same full force and effect as if an original of this Agreement had been delivered. Each of the parties (a) intend to be bound by the signatures on any

document sent by facsimile or electronic mail, (b) are aware that the other party will rely on such signatures, and (c) hereby waive any defenses to the enforcement of the terms of this Agreement based on the foregoing forms of signature.
