The Bidder which I represent complies with all applicable requirements of the Americans with Disabilities Act (ADA) and the Occupational Safety and Health Act (OSHA) and that if said bidder is awarded a contract, it will complete all OSHA-required or ADA-required employee and customer training, will make available all required information, and will hold harmless and indemnify the Four Rivers Sanitation Authority and the Four Rivers Sanitation Authority's representatives.
 - In regard to participation in an approved Apprenticeship program, upon request, Contractor will be required to provide written proof of participation.
- 9. The undersigned, as Bidder, declares that he has adopted and promulgated written sexual harassment policies in accordance with Public Act 101-0221 and will make this information available upon request.

II. Contract

- a. Signed and sealed bids due at 10:00 a.m. on Tuesday, September 10, 2024 at Four Rivers Sanitation Authority (FRSA) Steve Graceffa Administration Building located at 3501 Kishwaukee Street, Rockford, Illinois, at which time they will be read aloud.
- b. This is a unit price contract. All work necessary to complete the scope items will be considered incidental to the unit prices.
- c. Any interpretation of the plans, specifications, or other contract documents must be submitted in writing no later than September 5, 2024. The last day for addenda issuance will be September 6, 2024.
- d. The tentative award date is September 23, 2024.
- e. FRSA will issue a Notice of Award and within 10 days the successful bidder shall enter into a written contract for the performance of the proposed work and shall furnish the required bonds and insurance certificates.
- f. All work associated with the project shall be completed by November 15, 2024. Liquidated damages are \$300.00 per calendar day.

V. Ouestions

- Q: Will HM A pavement be placed directly on existing aggregate surface?
- A: Generally, the profile follows the existing aggregate surface resulting in 4" of cut. Where the profile varies from the existing aggregate surface, adjustments to the amount of cut will be necessary.
- Q: Is the depth of existing aggregate known?
- A: The depth of existing aggregate is not known, however, the same process was successfully used on the previously paved portion of driveway.
- Q: Will FRSA provide layout?
- A: FRSA will provide horizontal and vertical layout of the proposed aggregate base course and pavement limits. Coordinate desired offsets, etc. with FRSA Survey and Field Operations Manager Ben Christiansen at (815) 209-7952.
